Chapter 1

Introduction

1.1 Overview

This manual describes the theory which underlies the Spice cable bundle modelling software SACAMOS. The SACAMOS software generates a Spice subcircuit which models the propagation of signals on multi-conductor transmission lines i.e. cables and bundles of cables. The models include the effects of crosstalk, transfer impedance coupling and incident field excitation as required by the user. The frequency dependence of the transmission line parameters is taken into account in the model. The resulting models take the form of Spice sub-circuits which may be linked to arbitrary termination circuits. The use of the SACAMOS software and the resulting cable models is described in the accompanying user guide [1].

The document is structured as follows:

Chapter 2 describes the multiconductor transmission line equations which form the basis for the Spice cable bundle model. The chapter includes a discussion of the per-unit-length paramters which characterise a multi-conductor transmission line, the solution of the transmission line equations and the inclusion of termination conditions into the solution. The method for including the effect of a plane wave incident field illuminating a transmission line into the multi-conductor transmission line equations is also described.

Following this review of the theory of multi-conductor transmission lines, the Spice multi-conductor transmission line model is derived in chapter 3. The chapter provides an overview of the Spice model structure before describing the different aspects of the Spice cable bundle model; the domain decomposition approach to deal with shielded cables , the model for twisted pairs, the implementation of modal decomposition and the propagation model using method of characteristics (the technique used to incorporate the frequency dependent propagation model) and finally the transfer impedance coupling and incident field excitation models.

The ways in which the per-unit-length parameters of multi-conductor cables are calculated using a Finite Element method are described in chapter 4. The 'filter fitting' process which is used to create s-domain transfer functions for frequency dependent

aspects of the model is described in chapter 5. Finally the types of cable implemented in the software are described and the approximations made for each cable type are described in chapter 6.

Chapter 2

Multi-Conductor Transmission line theory

In this chapter we present the multi-conductor transmission line equations which underly the models which are used in the SACAMOS project. The fundamental approximations applied throughout this document are that the models produced will obtain quasi TEM propagation on cables and that the cables are uniform along their length [2]. The only non-uniformity along the length of the transmission lines that will be considered involves twisting of wire pairs.

2.1 Multi-Conductor Transmission line equations

The electrical state of a multi-conductor cable bundle is described by the voltage and current on each of the conductors. We assume that a multi-conductor cable bundle (including the ground plane) carries no common mode current, i.e. at any cross section of the cable normal to the propagation direction, z and at any time, t:

$$\sum_{n=1}^{n_{conductors}} I_n(z,t) = 0.$$

We note that this assumption does not preclude the use of the current distribution on the conductors in 3D space from being used to provide an estimate of radiation from a cable bundle. The currents induced by external fields may be common mode on the cables but differential with respect to ground. Finally it is assumed that there is no field interaction between the circuit subsystems (i.e. the interconnect can be broken down into separate elements).

The differential mode voltage, V, and current, I, on the conductors of a z directed multi-conductor cable bundle in the absence of sources may be described in the time




Figure 2.1 A multi-conductor cable showing the differential mode voltages and currents.

domain by the following equations:

$$\frac{\partial}{\partial z} (V(z,t)) = -[R] (I(z,t)) - [L] \frac{\partial}{\partial t} (I(z,t))$$

$$\frac{\partial}{\partial z} (I(z,t)) = -[G] (V(z,t)) - [C] \frac{\partial}{\partial t} (V(z,t)).$$
(2.2)

Here the cable bundle per-unit-length parameter matrices are inductance, [L], capacitance, [C], Resistance, [R] and conductance, [G]. We have implicitly assumed for the purposes of this initial discussion that these matrices are constant. We note that this is not the case in practice and the cable properties are frequency dependent which implies a convolution process in the time domain. The discussion of the generalisation of this theory to more realistic situations will be described in subsequent sections of this document.

For an n+1 conductor system the vectors and matrices are of dimension n where one of the conductors is chosen as a reference conductor. Typically the ground plane would be chosen as this reference. The voltage and current directions are shown in figure 2.1.

Values for these per-unit-length parameters can be obtained for some configurations by analytic expressions, such as for cylindrical conductors that are widely spaced (separation significantly larger than wire radius). In general these matrices can be obtained by numerical methods for the capacitance matrix, from which the other parameters can also be obtained. This involves the solution of the Laplace equation in the 2D cable cross section and can take account of dielectric materials inclusing dielectric losses. This is described in chapter 4.

The frequency domain equations corresponding to equation (2.2) are expressed as:

$$\frac{\mathrm{d}}{\mathrm{d}z} \left(\tilde{V} \left(z \right) \right) = -\left[R \right] \left(\tilde{I} \left(z \right) \right) - j\omega \left[L \right] \left(\tilde{I} \left(z \right) \right)

The resistance and inductance terms are conveniently combined into a single frequency dependent series impedance, similarly the capacitance and conductance terms

are combined into a single frequency dependent admittance term, this yields:

$$\frac{\mathrm{d}}{\mathrm{d}z} \left(\tilde{V}(z) \right) = -\left[\tilde{Z} \right] \left(\tilde{I}(z) \right)

where

This matrix formulation of the multi-conductor transmission line equations in frequency domain will be used in the next chapters to solve for currents and voltages on each conductor. It is also used for generating the models with frequency dependent cable parameters.

2.2 Per-Unit-Length Parameters

The multi-conductor transmission line equations express the transmission line voltages and currents in terms of the inductance, capacitance, resistance and conductance matrices.

This chapter describes the per-unit-length parameters of the transmission lines and gives some formulae which may be used for their evaluation. A detailed discussion of the per-unit-length parameters may be found in [2]

2.2.1 The per-unit-length inductance matrix

The inductance matrix relates the total magnetic flux, Φ linking the ith circuit to the currents which produce it

An element of the inductance matrix Lij may be calculated by putting a current on conductor j and zero current on all other conductors then

$$L_{i,j} = \frac{\Phi_i}{I_j} \bigg|_{I_{k \neq j} = 0} \tag{2.7}$$

2.2.2 The per-unit-length capacitance matrix

The capacitance matrix relates the charge , \mathbf{q} , on conductors to the conductor voltages, \mathbf{V} .

The capacitance matrix is commonly calculated from its inverse, the elements of the inverse capacitance matrix $[P] = [C]^{-1}$ are determined by placing a charge on conductor j and zero change on all other conductors then

$$P_{i,j} = \frac{V_i}{q_j} \bigg|_{I_{k \neq j} = 0} \tag{2.9}$$

then the capacitance matrix is found as

$$[C] = [P]^{-1} (2.10)$$

In a homogeneous medium the capacitance matrix may be found from the inductance matrix using

$$[C] = \mu_0 \epsilon_0 \epsilon_r \left[L \right]^{-1} \tag{2.11}$$

2.2.3 The per-unit-length resistance matrix

The per-unit-length resistance matrix, [R] incorporates the effects of conductor losses in the model i.e. the effects of the finite conductivity of the conductors. It relates the voltage drop along the transmission line to the currents on the conductors. The conductor resistance is a function of frequency due to the 'skin effect'. The calculation of the resitance of conductors, and the associated 'internal inductance' is discussed in section 3.6.2. The resistance matrix relates the conductor voltages and currents at zero frequency by

$$\frac{\partial}{\partial z} \begin{pmatrix} V_1 \\ V_2 \\ \vdots \\ V_n \end{pmatrix} = \begin{bmatrix} R_{1,1} & R_{1,2} & \dots & R_{1,n} \\ R_{2,1} & R_{2,2} & \dots & R_{2,n} \\ \vdots & \vdots & \ddots & \vdots \\ R_{n,1} & R_{n,2} & \dots & R_{n,n} \end{bmatrix} \begin{pmatrix} I_1 \\ I_2 \\ \vdots \\ I_n \end{pmatrix}$$

If a conductor i, i=1...n has a resistance R_i and the reference conductor has resistance R_0 then the resistance matrix is given by

$$[R] = \begin{bmatrix} R_1 + R_0 & R_0 & \dots & R_0 \\ R_0 & R_2 + R_0 & \dots & R_0 \\ \vdots & \vdots & \ddots & \vdots \\ R_0 & R_0 & \dots & R_n + R_0 \end{bmatrix}$$

2.2.4 The per-unit-length conductance matrix

The per-unit-length conductance matrix , [G] incorporates the effects of losses due to conductance of the medium in which the conductors are situated and also due to polarisation losses in dielectrics. The conductance loss will be assumed to be zero therefore the only contributions to the conductance matrix are due to lossy dielectrics. In this work the conductance matrix is calculated by generalising the capacitance matrix calculation to complex permittivities.

The admittance matrix is written as

$$[Y] = [G] + j\omega [C] = j\omega \left[C - \frac{j}{\omega} G \right] = j\omega [C']$$
 (2.14)

Thus if we determine the complex capacitance matrix [[C'] then we can calculate the capacitance matrix and admittance matrices as

$$[C] = \Re\{[C']\}\tag{2.15}$$

and

$$[G] = -\omega \Im \{ [C'] \} \tag{2.16}$$

The calculation of the capacitance and conductance matrices for configurations with lossy inhomogeneous dielectrics is discussed in section 4.

2.2.5 Exact analytic formulae for per-unit-length parameters

Exact analytical formulae are available for the inductance and capacitance of some conductor configurations. There are also approximations which may be made which allow the derivation of approximate analytic formulae. Where possible these formulae are used in the SACAMOS software. The derivation of the formulae presented in the following sections may be found in [2].




Figure 2.2 Coaxial cable

Figure 2.2 shows a coaxial cable

In SACAMOS, the inductance and capacitance of the coaxial cable is always calculated using the analytic formulae

$$L = \frac{\mu_0}{2\pi} \ln \left(\frac{r_s}{r_w} \right) \tag{2.17}$$

$$C = \frac{2\pi\epsilon_0\epsilon_r\left(j\omega\right)}{\ln\left(\frac{r_s}{r_w}\right)} \tag{2.18}$$

Figure 2.3 shows a two wire transmission line.



Figure 2.3 Two wire cable

The analytic formulae used to calculate the inductance and capacitance of the two wire transmission line are

$$C = \frac{\pi\epsilon_0}{\ln\left(\frac{s}{2r_w} + \sqrt{\frac{s}{2r_w}^2 - 1}\right)} \tag{2.19}$$

$$L = \frac{\mu_0 \epsilon_0}{C} \tag{2.20}$$

These formulae are used for the calculation of the differential mode inductance and capacitance for twisted pairs.

2.2.6 Approximate analytic formulae for per-unit-length parameters

Approximate analytic formulae are available for multi-conductor configurations where the assumption made is that the conductor radii are small compared to the conductor separation. It is also assumed that the conductors are perfectly conducting and are situated in a homogeneous dielectric (free space here).




Figure 2.4 Multi-wire cable

Figure 2.4 shows part of a multi-conductor configuration.

The analytic formulae used to calculate the inductance and capacitance of the multiwire transmission line are as follows:

For the diagonal elements of the inductance matrix

$$L_{ii} = \frac{\mu_0}{2\pi} \ln \left(\frac{d_{i0}^2}{r_{w0} r_{wi}} \right) \tag{2.21}$$

The off diagonal elements are given by

$$L_{ij} = \frac{\mu_0}{2\pi} \ln \left(\frac{d_{i0}d_{j0}}{d_{ij}r_{w0}} \right) \tag{2.22}$$

Since the conductors are in a homogeneous dielectric medium, the capacitance matrix is found from the inverse of the inductance matrix.

$$[C] = \mu_0 \epsilon_0 \left[L \right]^{-1} \tag{2.23}$$




Figure 2.5 Multi-wire cable over a ground plane

Figure 2.5 shows part of a multi-conductor configuration above a ground plane. Here the ground plane is the reference conductor

For the diagonal elements of the inductance matrix

$$L_{ii} = \frac{\mu_0}{2\pi} \ln \left(\frac{2h_i}{r_{wi}}\right) \tag{2.24}$$

The off diagonal elements are given by

$$L_{ij} = \frac{\mu_0}{4\pi} \ln \left(1 + \frac{4h_i h_j}{d_{ij}^2} \right) \tag{2.25}$$

Since the conductors are in a homogeneous dielectric medium, the capacitance matrix may be found from the inverse of the inductance matrix.

$$[C] = \mu_0 \epsilon_0 \left[L \right]^{-1} \tag{2.26}$$




Figure 2.6 Multi-wire cable inside a cylindrical shield

Figure 2.6 shows part of a multi-conductor configuration within a cylindrical shield. Here the shield is the reference conductor

For the diagonal elements of the inductance matrix

$$L_{ii} = \frac{\mu_0}{2\pi} \ln \left(\frac{r_s^2 - d_i^2}{r_s r_{wi}} \right)$$
 (2.27)

The off diagonal elements are given by

$$L_{ij} = \frac{\mu_0}{2\pi} \ln \left(\frac{d_j}{r_s} \sqrt{\left(\frac{d_i^2 d_j^2 + r_s^4 - 2d_i d_j r_s^2 \cos(\theta_{ij})}{d_i^2 d_j^2 + d_j^4 - 2d_i d_j^3 \cos(\theta_{ij})} \right)} \right)$$
(2.28)

Since the conductors are in a homogeneous dielectric medium, the capacitance matrix is found from the inverse of the inductance matrix.

$$[C] = \mu_0 \epsilon_0 \left[L \right]^{-1} \tag{2.29}$$

2.3 Solution to the Multi-Conductor Transmission line equations

The SACAMOS software includes the ability to set up a validation test for the Spice transmission line models. In the validation test a resistive termination circuit with series voltage sources is specified and the solution for conductor voltages calculated with the Spice transmission line model can be compared with the solution obtained using the frequency domain analytic solution. The frequency domain analytic solution is calculated on the basis of the full dimension multi-conductor transmission line equations (i.e. no domain decomposition) and therefore includes the self consistent model of transfer impedance coupling. All the parameters in the analytic solution implemented are frequency dependent. The comparison between the Spice solution and the analytic solution therfore allows the effect of the approximations made in the derivation of the Spice model to be tested.

This section outlines the solution of the transmission line equations defined in section 2.1. A more complete discussion of the multi-conductor transmission line equations may be found in [2].

2.3.1 Solution of the transmission line equations by modal decomposition

The impedance and admittance matrices are given by:

$$\begin{bmatrix} \tilde{Z} \end{bmatrix} = [R] + j\omega [L]$$

$$\begin{bmatrix} \tilde{Y} \end{bmatrix} = [G] + j\omega [C].$$

We can derive a frequency domain solution to the transmission line equations using a modal analysis. Equation 2.4 can be re-written as an uncoupled second order equation in the following ways:

$$\frac{\mathrm{d}^{2}}{\mathrm{d}z^{2}} \left(\tilde{V} \left(z \right) \right) = \left[\tilde{Z} \right] \left[\tilde{Y} \right] \left(\tilde{V} \left(z \right) \right)
\frac{\mathrm{d}^{2}}{\mathrm{d}z^{2}} \left(\tilde{I} \left(z \right) \right) = \left[\tilde{Y} \right] \left[\tilde{Z} \right] \left(\tilde{I} \left(z \right) \right).$$

A change of variables to modal quantities via a similarity transformation allows the decoupling (diagonalisation) of the matrix system. The conductor voltages and currents are related to their corresponding modal quantities by:

$$\tilde{V}(z) = \left[\tilde{T}_V\right] \left(\tilde{V}_m(z)\right)
\tilde{I}(z) = \left[\tilde{T}_I\right] \left(\tilde{I}_m(z)\right).$$
(2.32)

The voltage modal transformation matrix, $[T_V]$ diagonalises the first equation given in (2.31):

$$\frac{\mathrm{d}^{2}}{\mathrm{d}z^{2}}\left(\tilde{V}_{m}\left(z\right)\right) = \left[\tilde{T}_{V}\right]^{-1}\left[\tilde{Z}\right]\left[\tilde{Y}\right]\left[\tilde{T}_{V}\right]\left(\tilde{V}_{m}\left(z\right)\right)
= \left[\gamma^{2}\right]\left(\tilde{V}_{m}\left(z\right)\right),$$
(2.33)

where $\left[\gamma^2\right]$ is a diagonal matrix with elements whose values are the squares of the mode propagation constants. The elements of the diagonal matrix $\left[\gamma^2\right]$ are found as the eigenvalues of the $\left[Z\right][Y]$ product and the columns of the matrix $\left[\tilde{T}_V\right]$ are the corresponding eigenvectors. (We note that when there are repeated eigenvalues which may originate from the symmetry of the cable cross section, then the diagonalisation is not unique. The eigenvectors corresponding to these eigenvalues are only required to span a certain subspace of the original matrix. In this situation the eigenvector solver for general complex matrices in Eispack ([11]) may on rare occasions return the same eigenvector for more than one eigenvalue. In order to avoid this in practice we perturb the matrix by a very small amount in a manner which prevents this degeneracy).

In the lossless case the impedance matrices and admittance matrices are imaginary and symmetric, and the [Z][Y] product is real and symmetric. The modal transformation matrices are real and are independent of frequency and the diagonal $[\gamma^2]$ matrix has negative, real values of the form $-\frac{\omega^2}{v^2}$, where v is the mode velocity. Modal decomposition for a lossless transmission line will be important in the derivation of the Spice multi-conductor transmission line model derived in section 3.

The solution for the modal voltages at any point z on the multi-conductor transmission line may be written in terms of modes travelling in the +z and -z directions as:

$$\tilde{V}_m(z) = \left[e^{-\gamma z} \right] \left(\tilde{V}_m^+ \right) + \left[e^{+\gamma z} \right] \left(\tilde{V}_m^- \right). \tag{2.34}$$

The general solution for the actual conductor voltages is then:

$$\tilde{V}(z) = \left[\tilde{T}_V\right] \left(\left[e^{-\gamma z} \right] \left(\tilde{V}_m^+ \right) + \left[e^{+\gamma z} \right] \left(\tilde{V}_m^- \right) \right). \tag{2.35}$$

Similarly, the current modal transformation matrix [TI] diagonalises the second equation in (2.31):

$$\frac{\mathrm{d}^{2}}{\mathrm{d}z^{2}}\left(\tilde{I}_{m}\left(z\right)\right) = \left[\tilde{T}_{I}\right]^{-1}\left[\tilde{Y}\right]\left[\tilde{Z}\right]\left[\tilde{T}_{I}\right]\left(\tilde{I}_{m}\left(z\right)\right)$$

$$= \left[\gamma^{2}\right]\left(\tilde{I}_{m}\left(z\right)\right).$$
(2.36)

In practice we use the Fast Fourier Transform (FFT) algorithm to transform between the time and frequency domains [10]. The FFT algorithm assumes that the time response is discrete in time and periodic with period T i.e. we have a finite number of samples of the time response. These assumptions also make the frequency response periodic and discrete thus the analysis outlined above may be performed at a discrete set of frequencies. We assume that the time response may be adequately sampled at a sampling rate of δt and the period for the time response is chosen to be $T=n\delta t$ where n is conveniently chosen to be an integer power of 2. It is important that the period T is chosen to be long enough such that the time response of the transmission line has decayed to an insignificant level, otherwise the solution will be affected by aliasing i.e. the time response within a period T is corrupted by the response from adjacent periods.

2.4 Incident Field Excitation Model

An electromagnetic field illuminating a transmission line can couple energy onto the line and therefore be a cause of interferance. The effect of an incident field excitation may be included in the transmission line equations by distributed forcing functions I_F and V_F in the transmission line equations as described in references [3], [2] thus the transmission line equations with incident field excitation are written as




Figure 2.7 Equivalent circuit for the incident field excitaiton solution

Chapter 3

The Spice Cable Model

In this chapter we describe how the transmission line theory discussed in the previous chapter may be implemented using circuit elements and implemented as a Spice model.




Figure 3.1 Multi-conductor cable modelling scenario with shielded conductors and incident field excitation

The scenario which we are aiming to model is illustrated in Figure 3.1 The termination circuits are arbitrary and to be specified by the user. The proposed Spice model being considered here concerns the transmission line only, though we note that connectors, ground plane bonding straps, pigtails etc could be modelled as short lengths of transmission line cascaded with the main transmission line.

The model has been developed so as to include frequency dependent cable parameters arising from the finite conductivity of conductors, frequency dependent dielectrics and frequency dependent transfer impedance effects. This is a challenging requirement as in general the modal decomposition used in the analysis of the previous chapter

is a function of frequency. It is shown in section 3.6 that if the d.c. resistance of the conductors is lumped at the cable terminations then the modal decomposition becomes a weak function of frequency. Simulations show that the frequency dependence of the modal decomposition can be neglected and the decomposition based on lossless high frequency inductance and capacitance matrices can be used provided that the propagation of the individual modes is corrected for the propagation loss.

The spice model of the scenario depicted is based on a number of different parts these are:

- Domain decomposition: we model shielded conductor systems as separate domains, in which the electrical quantities are referenced the shielding conductor, plus the external domain consisting of the ground plane, unshielded conductors and the exterior surface of shields.
- Modal decomposition: Signal propagation on the multi-conductor system within
 each domain is analysed by a modal decomposition method i.e. we diagonalise
 the transmission line equations within each domain and propagate the modes on
 'modal transmission lines'
- Method of characteristics. The propagation of each mode is treated using the
 method of characteristics [2] i.e. modes are propagated in the +z and -z directions and the state of the transmission line is the combination of these +z and -z
 propagating modes.
- Frequency dependent propagation characteristics are dealt with using an approximate model in which the d.c. resistance is extracted and lumped at the ends of each transmission line and the frequency dependence of the propagation is dealt with by applying a frequency dependent propagation correction to the +z and -z propagating modes at the ends of the transmission lines.
- Incident field excitation is assumed to be a plane wave, in this model appropriate controlled source terms lumped at the cable terminations take account of the incident field excitation.
- Coupling through imperfect shields is modelled with transfer impedance terms
 and implemented in a weak form i.e. source and victim conductors are identified
 and one way coupling is implemented using appropriate controlled source terms
- The twisted pair model is derived on the assumption that there is no coupling between the differential mode and the other conductors within the bundle (or the shield for a shielded twisted pair) although coupling to the common mode is included. This model does however allow coupling from the common mode to the differential mode and vice versa, through unbalanced terminations.

In the subsequent sections each of these stages is treated in turn and theoretical model derivations and associated circuit diagrams will be presented.

3.1 Spice cable bundle model structure




Figure 3.2 Structure of the spice cable bundle model

Figure 3.2 shows the structure of the spice cable bundle model with a termination network. The termination network is an arbitrary network to be constructed by the user and does not concern us here. The spice cable bundle model consists of a number of cascaded elements. The major elements are (in order from the model terminals inwards)

- 1. d.c. conductor resistance
- 2. Domain decomposition network
- 3. Modal decomposition network
- 4. Souces to include transfer impedance and incident field excitation
- 5. Method of characteristics delay lines
- 6. Transfer impedance delay lines
- 7. Incident field delay lines

3.1.1 Terminology

In discussing the spice cable bundle model we require a clear terminology so as to allow unambiguous reference to particuar sections of the model.

Cable numbering always relates to the numbering of the cables within a bundle and is specified by the order in which they are included in the cable_spec file.

Within a cable there is a local numbering system for cables and domains within a cable e.g for a coaxial cable the inner wire is local_conductor 1 and the shield is local conductor 2. Similarly the inner coaxial domain is domain 1 and the external domain is domain 2.

Once a cable bundle is built a global numbering is introduced.

We adopt the terminology in table 3.1 both in this document and in the software itself:

3.2 Domain decomposition

The basis for computation of the systems being addressed in this work is the multiconductor cable bundle. A bundle consists of multiple individual cables. These cables may consist of shielded and/ or un-shielded conductors perhaps with the addition of over-shielding and a ground plane (satellite panel).

The spice cable bundle model decomposes the transmission line system into domains. The domains consist of an external domain whose conductors are exposed to the external EM environment and internal domains in which conductors are shielded from the external environment. These domains are assumed to be only weakly coupled through transfer impedance terms.

The domain decomposition method along with the weak coupling assumption leads to a smaller system of coupled equations and has the advantage of removing one of the strong frequency dependent effects, that of transfer impedance coupling, from the main propagation model.




Figure 3.3 Illustration of a cable bundle built with multiple layers of shielding

In an internal domain the natural reference conductor is the shield enclosing the domain. The model allows for multiple levels of shielding hence an internal domain may contain conductors which are themselves the shields of other domains as seen in Figure 3.3. In the case of imperfect shielding these domains are coupled through transfer impedance and admittance terms. In this work we assume that the coupling through transfer admittance may be neglected.




Figure 3.4 A shielded cable with alternative voltage and current definitions

When applying this decomposition technique the voltages on shielded cables are naturally referenced to their respective shields and the current return is also assumed to be on the inside of the shield. This can aid the propagation analysis and also the analysis of coupling from an external illuminating field. The internal and external propagation problems can be coupled by transfer impedance and admittance terms. We note that there may be more than one level of shielding in a particular cable installation and we must be able to take this into account in our analysis. Figure 3.4 shows a shielded cable with voltages and currents reference to their natural (local) references in blue on the right hand side and with voltages and currents referenced to the ground plane (global reference) on the right hand side.

We can define a domain decomposition matrix which transforms conductor voltages referenced to their local reference (shield for shielded conductors, ground for external conductors) and voltages referenced to the global reference (ground).

Figure 3.3 shows a complex cable bundle with multiple levels of shielding. In this case there are multiple local voltage references. The transformation matrices for these complex situations can be defined in a similar manner as for the coaxial cable.

The domain decomposition process is achieved by a matrix multiplication. This may be implemented in a Spice model using controlled voltage and current sources. In the example of the coaxial cable above a ground plane there are three conductors. We define the global voltage variables with respect to the ground plane as

Note that the voltage sources on the left hand side of the figure have a value of zero volts, they are only required as Spice uses such voltage sources as current sensing elements for the current controlled voltage sources.




Figure 3.5 Spice circuit model which implements domain decomposition for a shielded cable

3.3 Twisted Pair Model

The twisted pair model assumes that any crosstalk or coupling in the cable bundle (as opposed to the terminations) will be to the common mode of the twisted pair. The differential mode propagates without any coupling to or from other conductors in the bundle. This twisted pair model behaves in a similar manner to a shielded cable with a perfect shield where the differential mode corresponds to the internal (shielded) mode which does not interact with its surrounding conductors and the common mode corresponds to the external propagation on the shield which does interact with the surrounding conductors. This correspondence allows a circuit model of a twisted pair to be constructed based on the domain decomposition method used for shielded cables. The model decomposes the twisted pair system into domains. The domains consist of a common mode domain which is exposed to the external EM environment and a differential mode domain which is perfectly shielded from the external environment. In an internal domain the natural reference conductor is the shield enclosing the domain. The model may be simply extended to the case of a shielded twisted pair. Note that for a twisted pair in isolation i.e. with no other return conductor then only the differential mode should be included in the model.




Figure 3.6 Domain decomposition for twisted pairs

Figure 3.6 shows a twisted pair cable with an additional external conductor (ground plane). The external voltages and currents at the termination (LHS) are reference to ground plane (global reference) whilst the voltages and currents used in the model are the common and differential mode shown to the right.

For the twisted pair we can relate the differential mode and common mode voltages to the conductor voltages by

3.3.1 Per-unit-length parameters for the twisted pair model




Figure 3.7 Twisted pair inductance and capacitance matrix calculation

The decomposition into the differential mode and the common mode for the twisted pair model requires the per-unit-length inductance and capacitance to be determined for these modes. The differential mode of a twisted pair in a bundle with other conductors and/ or a ground plane is assumed not to interact with the other conductors in the bundle, the differential mode inductance and capacitance are calculated for the two conductors in isolation i.e. with all other conductors removed. The differential mode inductance and capacitance are then independent of the orientation of the conductors in the analysis. The common mode inductance and capacitance are calculated by assuming that the common mode current is carried by an equivalent cylindrical conductor placed on the axis of the twisted pair. This equivalent conductor is then used in the analysis of the bundle cross section in the calculation of the twisted pair common mode contribution to the inductance and capacitance matrices. This process is illustrated in figure 3.7

3.3.2 Per-unit-length parameters for the shielded twisted pair model

The per-unit-length parameters for a shielded twisted pair are determined in a slightly different manner than for a twisted pair in a bundle with other conductors. In the case of a shielded twisted pair the orientation of the conductors is not of any significance due to the symmetry of the shield conductor. The inductance and capacitance of the three conductor system formed by the twisted pair and the shield can be calculated using the Laplace solver with the shield chosen as the reference conductor. This gives the conductor based transmission line equations of the following form

The frequency domain solution of these equations relied on a modal decomposition method as described in section 2 in which the [Z][Y] product was diagonalised i.e. we must diagonalise the matrix

In the first case the [Z][Y] matrix product is dominated by [R] and [C] whereas at high frequency it is dominated by [L] and [L]. In the general case, we must therefore diagonalise the [Z][Y] matrix product at every frequency.

A model which eliminates this problem may be found by lumping the d.c. resistances of the conductors at the conductor ends i.e. place a lumped resistance with value $R_{dc}/2$ at either end of the transmission line. Once this is done, the [Z][Y] matrix product is again given by equation 3.26.

A justification for this is that the transmission line resistance may be attributed to the finite conductivity of the conductors. The resistance resulting from this is frequency dependent and increases as $\frac{1}{\sqrt{(f)}}$. Subtracting the d.c. resistance will result in a model which is still correct at d.c. and reasonably accurate provided the transmission line is short compared with the wavelength. The modal decomposition will be a weak function of frequency and the losses associated with the propagation of a mode on a lossy transmission line may be corrected by a frequency dependent loss term as described below.

It is interesting to observe that (if we consider a single mode transmission line), if there is a d.c. resistance present then the characteristic impedance of the lossy line is given by

Mode propagation will underly the method of characteristics based propagation algorithm in the Spice model.

This leads to an efficient algorithm for both a.c. and transient models of multiconductor propagation provided that the modal decomposition matrices are independent of frequency. Discussion of the incorporation of loss and frequency dependent properties will be discussed in sections 7.4 and 7.5.

For the example of a lossless 3 conductor cable the conductor currents are related to the modal currents by matrices of dimension 2:




Figure 3.8 Spice circuit model which implements modal decomposition for a three conductor system

A modal decomposition for a three conductor (two mode) transmission line is implemented by the network model in Figure 3.8. The model implements equations 3.49 and 3.50. As for the domain decomposition matrix implementation, the voltage sources on the left hand side of the figure have a value of zero volts, they are only required as Spice uses such voltage sources as current sensing elements for the current controlled voltage sources.

This model may be implemented in any of the Spice versions considered in this study and is suitable for a.c. and transient analysis. It may be extended to an arbitrary number of conductors under the assumption that the multi-conductor is lossless and non-dispersive.

3.5 Method of characteristics

The propagation of modes is implemented using the method of characteristics [2] i.e. we identify modes propagating in the +z and -z directions at the terminations and propagate these separately. This has advantages for incorporating incident field excitation and transfer impedance coupling processes. In the derivation of the method of characteristics model we consider a lossless, dispersionless single mode transmission line of length L. This analysis generalizes to multi-mode transmission lines where each mode is treated separately and so is sufficient for the derivation of the proposed model. If we consider the propagation of a mode with modal current, I, modal voltage, V, and modal characteristic impedance Zc then the voltage and current may be written as the sum of waves propagating in the +z and -z directions as

The voltage and current for the +z and -z waves are related by




Figure 3.9 Spice compatible circuit implementing the method of characteristics

In practice the Spice circuit which implements the calculation of the characteristic variables in equations 3.53 uses voltage controlled voltage sources. The following expression allows for the calculation of the characteristic variables in the +z direction from nodal voltage values at the z=0 termination.

3.6 Approximate model for frequency dependent transmission lines

The derivation of the model for frequency dependent transmission lines will be described in two stages. Firstly the model is described for single mode propagation. This model is subsequently generalised to multi-mode propagation. The frequency dependent properties in the models derived here arise from two mechanisms:

- 1. frequency dependent permittivity of dielectrics
- 2. finite conductivity of conductors.

3.6.1 Frequency dependent dielectric models

Frequency dependent cable properties (dielectric relative permittivity or transfer impedance) may be included in the model using the rational function form for the relative permittivity i.e.

For example the frequency dependent cable dielectric constant could be approximated by a Debye model [4] which has a relative permittivity (although in practice debye dielectrics would be too lossy to be used in transmission lines) described by

where ϵ_{∞} is the relative permittivity at the high frequency limit, ϵ_s is the relative permittivity at the low frequency limit and τ is the relaxation time of the material.

A frequency dependent dielectric model will then give rise to a frequency dependent admittance in the transmission line equations. We note however that the frequency dependent relative permittivity function in equation 3.60 will give rise to no admittance at d.c. The only mechanism which would give rise to a d.c. admittance would be a non-zero electrical conductivity in the dielectric.

3.6.2 Frequency dependent finite conductivity loss models

Cable losses arising from the finite conductivity of a conductor are incorporated into some of the cable models available. In these models the conductivity of the conductors are specified as parameters of the cable model. The cylindrical conductor loss models are based on reference [5] and the model for rectangular conductors is derived in [2] The models of finite conductivity of conductors include both a resistance and internal inductance (due to the magnetic field penetrating the conductor). These are frequency dependent and thus a complex internal impedance contributes to the impedance matrix of the idealised cable.

It is seen that the internal resistance due to finite conductivity increases as $\sqrt(f)$ and the internal inductance decreases as $\frac{1}{\sqrt{f}}$. This is important to note for the derivation of the propagation correction.

Cylindrical Conductor

For a cylindrical conductor of radius, r, and conductivity, σ , the internal impedance due to the magnetic field penetrating the conductor at frequency f is given by [5], [2]

For a cylindrical shell i.e. a cable shield of radius, r, thickness, t, and conductivity, σ , the surface impedance (neglecting small terms related to the curvature of the conductor) may be evaluated as follows [5]

The d.c. resistance of a shell of radius, r, and thickness, t, is

- 1. The internal inductance, $L_{int}(j\omega)$, decreases with frequency as $\frac{1}{\sqrt{f}}$.
- 2. The internal resistance, $R_{int}(j\omega)$, is equal to 0Ω at d.c.
- 3. The internal resistance, $R_{int}(j\omega)$, increases with frequency as \sqrt{f}
- 4. The capacitance, $C(j\omega) \to C_0$ as $\omega \to \inf$

thus as $\omega \to \inf$, we can assume that the inductance of the transmission line is L_0 and the capacitance of the transmission line is C_0 . The characteristic impedance of the transmission line is

Multiplication in the frequency domain implies a convolution in the time domain therefore the frequency dependent propagation and the frequency dependent impedance functions require convolution processes for time domain calculations. It has been found that a sufficiently accurate model across a wide frequency band down to d.c. and up into the GHz frequency range may be derived by a suitable extraction of the loss and dispersion effects to the terminations of the transmission line model. The first complication in equations 3.74 and 3.75 is the frequency dependent impedance. This is simplified firstly by assuming that the d.c. resistance of the transmission line, R_{dc} , can be lumped into two resistances $\frac{R_{dc}}{2}$ at either end of the line. The impedance of the transmission line with the d.c. resistance removed in this way is now




Figure 3.11 Reciprocal method of characteristics Spice model with propagation correction

The implementation of the propagation correction for each mode is identical to that described in the previous section. The derivation of the correction factor as described above relies on being able to uniquely identify each mode of the frequency dependent transmission line with a corresponding mode of the frequency independent transmission line. The voltage transformation matrix $[T_v]$ which diagonalises the frequency dependent system in equation (7.57) has been found to be a weak function of frequency and hence the mode identification has been straightforward. We note that identifying the corresponding modes of the lossy transmission line and the lossless transmission line may require some care. In the implementation of this process we identify the modes on the lossy transmission line by identifying the closest mode of the lossless transmission line (using the vector norm as a distance measure). The propagation correction for the twisted pair model must take proper account of the domain decomposition. The propagation correction is developed as follows:

In the first stage the d.c. resistance of the conductors is lumped at the ends of the cable bundle model before the domain decomposition.

As derived in section 3.6 the propagation of the differential mode can be implemented as a simple delay line followed by a frequency dependent correction factor $H(j\omega)=e^{j\left(\gamma'(j\omega)-\gamma_0\right)L}$ where γ' takes account of the extraction of the d.c. resistance for the differential mode. The differential mode current sees the twice the impedance contribution of a single wire i.e. $(2R_{dc})$, twice the resistance of a single wires is subtracted.

The common mode is slightly different in that the common mode current is distributed between the two twisted pair conductors in parallel so the contribution to the loss of the common mode is $(\frac{1}{2}R_{dc})$, i.e half the resistance of a single wires is subtracted (note that any resistance in the common mode return must be subtracted too).

3.7 Transfer Impedance Model

The spice model for trasfer impedance coupling through cable shields uses a weak form of transfer impedance coupling i.e. the coupling is assumed to be in one direction only from source to victim domains. This requires identification of the source and victim domains by the user in each scenario. Transfer admittance is not included in the shield coupling model.

In this work the transfer impedance is assumed to take the form of a rational function in $j\omega$ i.e.

The model will be derived initially for a single mode in the source and victim domain before generalising to the multi-mode situation. In the derivation losses are assumed to be zero as we are using the 'propagation correction' model in which the effect of losses are lumped into the terminations as a lumped d.c. resistance and a propagation correction applied to the forward and backward modes on the transmission line.

The transfer impedance model derivation starts from the frequency domain equations for propagation in the victim domain.

It has been found that this approximation can lead to errors at high frequency for shielded cables whose shields are terminated with very low (comparable with the shield resistance at d.c. or less). In this situation, improved results are obtained by excluding the R_{dc} value from the process of lumping the d.c. resistances at the terminations and keeping it in the transfer impedance model. A flag is available when running the software to use this alternative model. The price to be paid for this is accuracy of the model at low frequency. It is recommended that a suitable validation test be run to test which model is most appropriate in any given circumstance.






Figure 3.12 Spice circuit for the simulation of souce and victim domain modes with the method of characteristics with additional source term for transfer impedance coupling




Figure 3.13 Spice circuit for the simulation of souce and victim domain modes with the method of characteristics: Delay lines for transfer impedance cource term




Figure 3.14 Spice circuit for the special case $T_s = T_v$




Figure 3.15 Specification of the incident field




Figure 3.16 Specification of the incident field polarisation




Figure 3.17 Spice circuit for the simulation of a multi-conductor transmission line illuminated by a plane wave




Figure 3.18 Spice circuit for the special case $T_i = T_z$

3.9 Spice Incident Field Excitation Model for shielded cables

The development of Spice models for incident field excitation and also for transfer impedance coupling have been described in sections 3.8 and 3.7. It has been shown in reference [7] that a rigorous model of incident field excitation of shielded cables can be derived. This section provides an outline of the analysis presented in reference [7] and gives the main results as implemented in the SACAMOS software.




Figure 3.19 Spice circuit for the victim domain mode direct transfer impedance incident field coupling model

The only change to the main circuit in figure 3.12 is that there is an additional source term in series with the ususal transfer impedance coource term at the z=0 and z=L terminations of the victim transmission line as shown in figure 3.19.

As for the incident field model and the transfer impedance model, there are circumstances in which terms in equations 3.197 to 3.200 need to be modified i.e. when $T_z - T_{sm} = 0$, $T_{vm} - T_{sm} = 0$ or $T_z - T_{vm} = 0$. In these cases the terms required are again (as in sections 3.8.1 and 3.7.2) shown to become time derivatives of the delayed incident field function which can be realised by circuits similar to that in figure 3.18 using a delay line and a 1H inductor in parallel with a controlled current source.




Figure 3.20 Delay lines required to implement the direct transfer impedance incident field coupling model

Chapter 4

Numerical computation of the per-unit-length MTL parameters using a FEM solver

Multiconductor Transmission Line (MTL) modelling is based on a set of coupled first order phasor MTL equations as discussed in chapter 2. In the set of coupled first-order MTL equations the impedance matrix $\left[\tilde{Z} \left(\omega \right) \right]$ and admittance matrix $\left[\tilde{Y} \left(\omega \right) \right]$ are given by

In order to be able to perform a propagation or crosstalk analysis using MTL modelling it is important to determine good approximations of these per-unit length parameter matrices.

It is assumed in the initial discussion that the inductance and capacitance matrix are independent of frequency and that dielectrics are loss-less and frequency independent. In section 4.2.3 frequency dependent capacitance is introduced by means of a complex relative permittivity. In this case the capacitance and conductance matrix may be evaluated at specific frequencies.

In the book by Paul, [2], chapter 5, a definition of the [L], [G] and [C] matrices is given and it is explained that these matrices can be determined from static field solutions in

the transverse plane for perfect line conductors. Closed-form solutions for these static field problems however only exist for a small set of configurations and several approximate solutions have limited applicability. As a consequence approximate numerical methods must be used for the computation of the entries in the per-unit-length matrices. In the same book by Paul, chapter 5, it is also shown that in order to numerically determine the entries of the [L], [G] and [C] matrices we only need a capacitance solver, that is, we only need a numerical solver that is able to compute a capacitance matrix [C]. The inductance matrix [L] can be derived from the capacitance matrix solution $[C_0]$ for the static field problem in which we have replaced all dielectrics in the cross-section with free space, the per-unit-length inductance matrix can be obtained from

Two dimensional electrostatic field problems are governed by the two-dimensional Poisson equation

with ϕ the potential, ρ_c the charge density, ε_0 the permittivity of free space, $\varepsilon_{r,x}$ and $\varepsilon_{r,y}$ the diagonal components of the relative permittivity tensor (we have assumed all off-diagonal terms are zero) of the materials in the configuration.

We can solve the capacitance matrix, [C], by discretising the cross-section of the cable (MTL) and solving the Laplace equation for this cross section numerically.

The two-dimensional Poisson equation follows from Gauss's law,

the constitutive relation between the electric flux density and the electric field intensity for a linear axial medium

In the static field problems that need to be solved in order to determine the entries of the capacitance matrix of a MTL, there is no free charge in the region between the conductors and the potential is prescribed on the conductors. As a result we have to solve the two dimensional field problem:

In the SACAMOS project the capacitance (and conductance) matrices are calculated numerically using a Finite Element Method [8] as outlined in the rest of this chapter. Details of the implementation are not discussed here however the software closely follows the process described in chapter 4 of [8].

4.1 Solving the capacitance matrix based on energy

The capacitance matrix can be solved based on energy or based on charges. We will use the method based on energy.

The total electrostatic energy stored in the multi-conductor configuration can be computed from the static field solution as

For this method we set the pth and qth conductor to 1V, that is, $V_{\rm p}=V_{\rm q}=1$ and connect all other conductors to reference, that is, all other conductors are set to 0V which implies $V_{\rm i}=0$ for all i \neq q or p, the electrostatic energy $W_{\rm pq}$ stored in the system equals

where c_{pq} is the coupling capacitance. As a result, in case we have determined W_p for all $p=1,\cdots,n$ and W_{pq} for all combinations of $p=1,\cdots,n$ and $q=1,\cdots,n$ for which $p\neq q$ we can first compute all coupling capacitances c_{pq} , namely

So, with a static field solver available we are able to compute the entries in the capacitance matrix.

4.2 Procedure capacitance matrix computation based on energy analysis

The procedure for determining the capacitance matrix via computation of the energy storage is:

1. First select all n non-reference conductors one after another and each time compute the static field solution with the voltage of the conductor under consideration set to 1V and all other conductors set to the reference 0V. With the pth conductor set to 1V ($V_{\rm p}=1{\rm V}$) and all other conductors to reference (0V), compute the

electrostatic energy $E_{\rm p}$ stored in the configuration by using the surface integral (4.10). This requires that the static field problem and energy integral has to be determined a total of n times.

- 2. Second select all combinations of two different conductors from the n non-reference conductors one after another and each time compute the static field solution with the voltage of the two conductors under consideration set to 1V and all other conductors set to the reference 0V. With the p^{th} and q^{th} conductor set to 1V ($V_p = V_q = 1$) and all other conductors set to reference (0V), compute the electrostatic energy E_{pq} stored in the configuration by using the surface integral (4.10). This requires that the static field solution and energy integral has to be determined a total of n(n-1)/2 times.
- 3. Determine the entries of the capacitance matrix from the computed stored energies $E_{\rm p}$ and $E_{\rm pq}$ using expressions (4.14) and (4.15).

The reference conductor can be either a ground plane, a shield or a circular or rectangular conductor.

4.2.1 FEM Solver for the Open Boundary Electrostatic Field Problem

Without an outer shield the electrostatic field is no longer confined to a bounded domain while the FEM can only be used on a finite computational domain. In the course of time a number of techniques have been developed to circumvent this problem. A review of the most important finite element open boundary techniques is given by Chen and Konrad [9]. Of all available techniques we have chosen to truncate the domain by introducing a fictitious contour that encloses the domain of primary interest and prescribe on it an asymptotic boundary condition which mimics the behaviour of the electrostatic potential in the region outside the contour. Not only has it been shown that asymptotic boundaries give good results, the technique is relatively easy to implement and preserves the sparsity of the finite element coefficient matrix which makes it a very efficient method as-well.

4.2.2 Asymptotic Boundary Conditions

For electrostatic problems, the potential in a point \mathbf{r} , can be written as

Where Ω is the charged region, $\rho(\mathbf{r}')$ is the charge distribution and $G(\mathbf{r}, \mathbf{r}')$ is the free space Greens function:

In the expression for the potential , the effect of dielectrics is taken into account by incorporating the polarization charge density in the charge distribution. Using polar coordinates (r,θ) the position vectors may be written as $\mathbf{r}=(r\cos\theta,r\sin\theta)$ and $\mathbf{r}'=(r'\cos\theta',r'\sin\theta')$ and the free space Green function equals

4.2.3 Computing the conductance matrix

The conductance matrix [G] can be obtained by introducing a complex permittivity and solving for a complex valued capacitance matrix [C]. (reference [2] equation 3.6.1)

If the surrounding medium is homogeneous, G can be obtained from C or L by

 \mathcal{L}_e is the external inductance matrix assuming perfect conductors.

Next we want to obtain G for inhomogeneous media. This can be the case for a conductor or shield that has a dielectric jacket (insulator). Actually, this is a simple modification of the calculation of the per-unit-length capacitance matrix C (also computed assuming perfect conductors). Losses in the medium are due to:

- Conductive losses (due to the conductance parameter σ).
- Polarization losses

Both of the losses can be represented by a complex permittivity.

where $tan(\delta)$ is the loss tangent and ε_b are the polarization losses due to bound charges. σ represents the conduction current losses.

We can include losses in the medium by solving for the capacitance matrix for a medium having a complex permittivity

Chapter 5

Frequency dependent transfer functions

5.1 Introduction

Frequency dependent transfer functions are implemented in the Spice models using s-domain transfer functions, this includes the propagation corrections and transfer impedance terms. The coefficients of the s-domain transfer functions are required to provide the 'best fit' to a frequency dependent transfer function evaluated at a discrete set of frequencies. The software includes a process whereby the coefficients of an s-domain transfer function (taking the form of a rational function in s), which provides an approximation to a function, are determined.

5.2 Filter fitting process for s-domain transfer functions

The process implemented is based on that described in [12].

The starting point for the process is a set of complex transfer function values $H'(j\omega_i)$ at a set of discrete frequencies i=1..n and the aim is to find a rational function $H(j\omega)$ which best fits the available data points.

The transfer function takes the form:

Stability of the transfer function

The spice models are required to operate in the time domain which implies that all transfer functions in the model should be causal and that their impulse response should not diverge as $t \to \infty$. This implies that all poles of the transfer function H(s) should lie in the left hand side of the s-plane. This condition is not naturally enforced by the method described above however experience has shown that if the function to be fitted is a physically reasonable then the filter fit process will produce a stable model.

Enforcing constraints on the transfer function

It may be the case that the transfer function is subject to constraints. If this is the case then the process may be adapted such that the constraints are naturally enforced. The filter fitting process is applied in a number of different aspects of the model. the filter fit required for the propagation correction function is subject to the constraint that $H(\omega=0)=1$. In this case we calculate a model fit to $H'(\omega)=H(\omega)-1$ where $H'(\omega=0)=0$ thus $a'_0=0$ for the initial model. Once we have the coefficients for the initial model we can easily calculate the filter coefficients for $H(\omega)=1+H'(\omega)$.

Chapter 6

Cable models available


In this section each of the cable types available will be described and any assumptions regarding the specific cable models will be described.

The cable models available are

- 1. Frequency Dependent Cylindrical conductor with dielectric
- 2. Frequency Dependent Coaxial cable with transfer impedance and shield surface impedance loss
- 3. Frequency Dependent Twinax cable with transfer impedance and shield surface impedance loss
- 4. Frequency Dependent Twisted pair
- 5. Frequency Dependent Shielded twisted pair with transfer impedance and shield surface impedance loss
- 6. Frequency Dependent Spacewire with transfer impedance and shield surface impedance loss
- Frequency Dependent Overshield with transfer impedance and surface impedance loss
- 8. Frequency Dependent flex cable
- 9. D connector

For each cable type the method of calculation for the inductance and capacitance matrices for any internal domains will be outlined. The domain decomposition matrices which relate local domain based voltages and currents to global condcutor based voltages and currents will be shown. These domain decomposition matrices for cables will be augmented to include an external (reference) conductor which allows the cable to carry a common mode current.

6.1 Frequency Dependent Cylindrical conductor with dielectric

The cylindrical conductor has no shielded conductors so no inductance/ capacitance matrix calculation has to be performed for internal domains.





The twinax cable has a single internal domain in which two modes propagates. The inductance and capacitance matrices for the internal domain are calculated using the Laplace solver.








Figure 6.6 Spacewire

Spacewire consists of 13 conductors configures as four shielded twisted pairs within an overshield. There are 5 shields, four surrounding the twisted pairs and the domain consisting of the shields surrouding each of the twisted pairs and the overshield. As each of the shielded twisted pairs is modelled using two domains (differential and common mode for the twisted pair) then there is a total of 9 internal domains in the spacewire model.

The inductance and capacitance for the shielded twisted pair differential and common mode are calculated as for the shielded twisted pair model described in section 6.5. The 4×4 inductance and capacitance matrices for the domain consisting of the twisted pair shields and the overshield are calculated using the Laplace solver.




Figure 6.7 Over shield

The overshield is a single conductor which may enclose other conductors within a cable bundle. As the internal conductor structure is not known at the cable model building stage there is no internal domain information at this stage. For the same reason the domain decomposition matrices only describe the external domain. Information relating to any enclosed conductors will be built at the cable bundle building stage.




Figure 6.8 flex cable




Figure 6.9 D connector

A D connector may have an arbirary number of conductors, N_c consisting of N_c-1 internal conductor pins and the outer shell.

Chapter 7

Network synthesis for specified frequency dependent transfer functions

7.1 Overview

It has been found from experience that Spice models making use of s-domain transfer functions to simulate frequency dependent transfer functions in Spice were susceptible to fail due to convergence problems, especially for transient analysis in Ngspice. An initial investigation of this issue showed that when the s-domain transfer functions were replaced by equivalent passive circuits which implemented the same transfer function, the convergence problems could be eliminated. This initial investigation was limited to first and second order rational functions only, however this observation has lead to the development of a general implementation of s-domain transfer functions as passive circuits so that the convergence issues can be mitigated for the general case.

This chapter describes the theory which underlies the modelling of frequency dependent transfer functions as passive circuits in Spice. Frequency dependent transfer functions in this work are represented as rational functions in tha laplace variable, s. It is assumed that the rational functions represent stable systems i.e. that their impulse response does not diverge as $t \to \infty$. This implies that the poles of the transfer function must lie in the left hand side of the s plane.

We consider two types of transfer functions according to their properties

- 1. Positive-real transfer functions which may be represented as a one port network (simple impedance)
- non-positive-real transfer functions which may be represented as two port networks

The first type of transfer function arises in this work in the propagation correction functions. The second type may arise in transfer impedance models where the transfer

resistance and/or inductance may be negative at some frequencies.

The form of the transfer functions that we wish to implement as a passive circuit are rational functions as in equation 7.1

$$H(s) = \frac{a_0 + a_1 \left(\frac{s}{\omega_0}\right) + a_2 \left(\frac{s}{\omega_0}\right)^2 + \dots}{b_0 + b_1 \left(\frac{s}{\omega_0}\right) + b_2 \left(\frac{s}{\omega_0}\right)^2 + \dots}$$

where ω_0 is a frequency normalisation factor. The methods applied make use of the work of Foster Cauer[13], [14], and Brune [15]. The underlying theory and examples of the techniques outlined here are described in reference [16].

7.2 One port impedance models for positive-real transfer functions

A passive impedance function must be 'positive-real' to constitute a physical impedance which can be synthesised from a network of inductors, capacitors, resistors and transformers. A positive-real rational function is defined by the following conditions:

- 1. The real part of the function Z(s) must be positive for all $s = \alpha + j\omega, \alpha > 0$
- 2. The imaginary part of the function Z(s) must be zero for all $s = \alpha + j\omega, \omega = 0$

Positive real rational functions have the following properties:

- 1. The number of poles and zeros differ by at most 1
- 2. The coefficients of the rational function are all real and positive
- 3. The poles and zeros of the function must lie in the left hand side of the s-plane or on the $s=j\omega$ axis
- 4. If a function Z(s) is positive-real then so is $Y(s) = \frac{1}{Z(s)}$

In this section we describe how an impedance represented as a rational function in s may be synthesised by a passive one port circuit consisting of resistors, inductors, capacitors and transformers i.e. Spice R, L, C and K elements.




Figure 7.1 One port network model of a positive-real transfer function




Figure 7.2 Ladder network synthesis of an impedance

Figure 7.1 shows a one port network driven by a current source $I(j\omega)$ whose port voltage is given by $V(j\omega) = Z(j\omega) I(j\omega)$. The impedance can be synthesised as a ladder network as shown in figure 7.2 The impedance of the ladder network may be expressed as the sum of the first series impedance, $Z_1(s)$ and a remainder, $Z_{r1}(s)$ i.e.

$$Z(s) = Z_1(s) + Z_{r1}(s) (7.2)$$




Figure 7.3 Initial stage of ladder network synthesis

The circuit is shown in figure 7.3 where $Z_1(s)$ is the impedance of a combination of R, L, C, K elements and $Z_{r1}(s)$ is a stable positive real function. The remainder




Figure 7.4 Second stage of ladder network synthesis

impedance, $Z_{r1}(s)$, is then synthesised as the parallel combination of the admittance function $Y_2(s)$ and a remainder, $Y_{r2}(s)$ as seen in figure 7.4

The admittance $Y_{r2}(s)$ is then synthesised as the sum of two series impedances i.e.




Figure 7.5 Third stage of ladder network synthesis

It is seen from this that the impedance function of the ladder network is expressed in a continued fraction form with alternating impedance and admittance terms. The circuit at this third stage is shown in figure 7.5. This synthesis procedure in which admittance and impedance elements of the ladder network are identified in turn continues until the remainder term is reduced to zero. This leads to a relatively straightforward synthesis process for impedance functions.

7.2.1 Algorithm for impedance synthesis

The starting point for the algorithm for impedance synthesis is a rational function in s which must be stable and positive-real. The impedance is synthesised by extracting series impedances and parallel admittances in turn until the remainder is zero. The impedance/ admittance extraction makes use of a pole-residue representation of the transfer function in order to identify branches which are combinations of R, L and C elements. This method can get stuck in that a viable branch cannot be identified while leaving a stable positive-real remainder function. In this case a technique developed by Brune [15] is used to continue the synthesis. Brune's method makes use of transformers (K elements in Spice).

An outline of the algorithm is as follows:

- 1. Attempt to identify a viable series impedance branch i.e. a branch which may be synthesised with R, L, and C elements and which leaves a remainder $Z_r(s)$ which is stable and posistive-real. If a viable branch is found then this process can be repeated until no further viable series impedance branches can be found.
- 2. Once no futher viable series impedance contributions can be found, calculate the admittance $Y_r(s) = 1/Z_r(s)$ and attempt to identify a viable parallel admittance branch i.e. a branch which may be synthesised with R, L, and C K elements and which leaves a remainder $Y_r(s)$ which is stable and posistive-real. If a viable branch is found then this process can be repeated until no further viable parallel admittance brances can be found.
- 3. If no viable series impedance branches or parallel admittance branches can be found then use the Brune synthesis method and implement the resulting circuit with R, L, C and K elements
- 4. Return to step 1 and repeat until the remainder impedance/ admittance is zero.

7.2.2 Identification of series impedance branches

A vaiable series impedance branch can be one of the following:

- 1. RLC branch
- 2. LC branch
- 3. RC branch
- 4. RL branch
- 5. C branch
- 6. L branch
- 7. R branch (which may be identified in two different ways)




Figure 7.6 Series Impedance Branches

These branches are shown in figure 7.6

Viable branches are found by first forming a pole-residue expansion of the impedance function where poles and their corresponding residues may be real or may be complex conjugate pairs i.e.

$$Z(s) = R + sL + \sum_{i=1}^{n_real_poles} \frac{r_i}{s - p_i} + \sum_{i=1}^{n_complex_pole_pairs} \frac{r_i}{s - p_i} + \frac{r_i^*}{s - p_i^*}$$

Then each of the branch types is looked for in the pole-residue expansion in the order of the above list. Each of the following subsections shows how each of the above branch types may be identified from the pole-residue expansion.

RLC impedance branch

The RLC impedance branch has an impedance function which can be expressed in rational function as

$$Z(s) = \frac{\frac{s}{C}}{\frac{1}{LC} + \frac{s}{CR} + s^2}$$

This may be expressed in pole-residue form as the complex pole-residue pair

$$Z(s) = \frac{r}{s-p} + \frac{r^*}{s-p^*} = \frac{(rp^* - r^*p) + (r+r^*)s}{pp^* - (p+p^*)s + s^2}$$

Where the poles are complex (and not purely imaginary). Equating coefficients of the rational functions a requirement for a viable RLC branch can be established i.e. the numerator constant term is zero:

$$rp^* - r^*p = 0 (7.9)$$

In addition we require that all the component values of the RLC circuit be positive i.e.

$$C = \frac{1}{r + r^*} > 0 (7.10)$$

$$L = \frac{r + r^*}{pp^*} > 0 (7.11)$$

The final requirement is that the remainder function be positive real i.e. the remaining terms of the impedance function describe a physical impedance. If these requirements are satisfied then a RLC branch can be extracted from the impedance function and implemented as an impedance branch in the ladder network.

LC impedance branch

The LC impedance branch has an impedance function which can be expressed in rational function as

$$Z(s) = \frac{\frac{s}{C}}{\frac{1}{LC} + s^2} \tag{7.13}$$

This is a special case of the RLC branch in which $R\to\infty$ may be expressed in poleresidue form as the complex pole-residue pair

$$Z(s) = \frac{r}{s-p} + \frac{r^*}{s-p^*} = \frac{(rp^* - r^*p) + (r+r^*)s}{pp^* - (p+p^*)s + s^2}$$
(7.14)

Where the poles are purely imaginary. Equating coefficients of the rational functions a requirement for a viable LC impedance branch can be established i.e. the poles are imaginary:

In addition we require that all the component values of the LC circuit be positive i.e.

The final requirement is that the remainder function be positive real i.e. the remaining terms of the impedance function describe a physical impedance. If these requirements are satisfied then an LC branch can be extracted from the impedance function and implemented as an impedance branch in the ladder network.

RC impedance branch

The RC impedance branch has an impedance function which can be expressed in rational function as

$$Z(s) = \frac{\frac{1}{C}}{\frac{1}{RC} + s} \tag{7.19}$$

This may be expressed in pole-residue form as

$$Z(s) = \frac{r}{s-n} \tag{7.20}$$

Where the pole and residue are both real. By equating coefficients of the functions, values of R and C can be identified We require that all the component values of the RC circuit be positive i.e.

$$C = \frac{1}{r} > 0 (7.21)$$

$$R = \frac{-r}{p} > 0 \tag{7.22}$$

The final requirement is that the remainder function be positive real i.e. the remaining terms of the impedance function describe a physical impedance. If these requirements are satisfied then an RC branch can be extracted from the impedance function and implemented as an impedance branch in the ladder network.

RL impedance branch

The RL impedance branch has an impedance function which can be expressed in rational function as

$$Z(s) = \frac{sR}{\frac{R}{I} + s} = R - \frac{\frac{R^2}{L}}{s + \frac{R}{I}}$$

This may be expressed in pole-residue form, including a constant term as

$$Z\left(s\right) = K + \frac{r}{s - p} \tag{7.24}$$

Where the pole and residue are both real. By equating coefficients of the functions, values of R and L can be identified We require that all the component values of the RL circuit be positive i.e.

$$R = \frac{r}{p} > 0 \tag{7.25}$$

The final requirement is that the remainder function be positive real i.e. the remaining terms of the impedance function describe a physical impedance. If these requirements are satisfied then an RL branch can be extracted from the impedance function and implemented as an impedance branch in the ladder network.

Capacitance branch

The capacitance branch has an impedance function which consists of a pole at zero i.e.

$$Z\left(s\right) = \frac{1}{sC} \tag{7.27}$$

Thus in the pole-residue expansion we require a pole at zero. In addition we require that capacitance be positive i.e.

$$C = \frac{1}{r} > 0 (7.28)$$

The final requirement is that the remainder function be positive real i.e. the remaining terms of the impedance function describe a physical impedance. If these requirements are satisfied then a capacitance branch can be extracted from the impedance function and implemented as an impedance in the ladder network.

Inductance branch

The inductance branch has an impedance given by

$$Z\left(s\right) = sL\tag{7.29}$$

Thus in the pole-residue expansion we require a sL term (pole at infinity in the impedance function) with positive inductance, L. The final requirement is that the remainder function be positive real i.e. the remaining terms of the impedance function describe a physical impedance. If these requirements are satisfied then an inductance branch can be extracted from the impedance function and implemented as an impedance in the ladder network.

Resistance branch, type 1

The resistance branch of type 1 is identified by a positive constant term, R, in the pole-residue expansion of the impedance. If the remainder function is positive real i.e. the remaining terms of the impedance function describe a physical impedance then a resistance branch can be extracted from the impedance function and implemented as an impedance in the ladder network.

Resistance branch, type 2

The resistance branch of type 2 may be found from the rational function form of the impedance i.e. if

$$Z(s) = \frac{a_0 + a_1 \left(\frac{s}{\omega_0}\right) + a_2 \left(\frac{s}{\omega_0}\right)^2 + \dots}{b_0 + b_1 \left(\frac{s}{\omega_0}\right) + b_2 \left(\frac{s}{\omega_0}\right)^2 + \dots}$$
(7.30)

then we can calculate the resistance, R as

as opposed to the pole-residue form whose constant (resistance) term is found as the ratio of the numerator and denominator coefficients of the highest power of s subtracting the resistance as defined in 7.31 results in a remainder impedance function with a pole at infinity. As for all the other branch identification methods, this resistance branch can only be extracted if the remainder impedance is a stable physical impedance function.

7.2.3 Identification of admittance branches

A vaiable admittance branch can be one of the following combinations:

- 1. GLC branch
- 2. LC branch
- 3. GC branch
- 4. GL branch
- 5. C branch
- 6. L branch
- 7. G branch (which may be identified in two different ways)




Figure 7.7 Parallel Admittance Branches

These branches are shown in figure 7.7 and are seen to be the duals of the corresponding impedance branches in figure 7.6. The dual circuits are found by the transformations

The admittance branches are found in the same was as for the series impedance branches i.e. viable branches are found by first forming a pole-residue expansion of the admittance function where poles and their corresponding residues may be real or may be complex conjugate pairs i.e.

$$Y\left(s\right) = G + sC + \sum_{i=1}^{n_real_poles} \frac{r_i}{s - p_i} + \sum_{i=1}^{n_complex_pole_pairs} \frac{r_i}{s - p_i} + \frac{r_i^*}{s - p_i^*} \quad (7.33)$$

For completeness a brief summary of the admittance branch identification processes is given here. The admittances may have inductance, capacitance or conductance though a non-zero conductance is implemented as a resistance $R=\frac{1}{G}$ in Spice.

GCL admittance branch

The GCL admittance branch has an admittance function which can be expressed in rational function as

The poles are complex (and not purely imaginary). Equating coefficients of the rational functions a requirement for a viable GCL admittance branch can be established i.e. the numerator constant term is zero:

LC admittance branch

The LC admittance branch has an admittance function which can be expressed in rational function as

This is a special case of the GCL branch in which $G \to \infty$ $(R \to 0)$ may be expressed in pole-residue form as the complex pole-residue pair

Where the poles are purely imaginary. Equating coefficients of the rational functions a requirement for a viable LC admittance branch can be established i.e. the poles are imaginary:

$$p^* + p = 0 (7.42)$$

The numerator constant term is zero:

$$rp^* - r^*p = 0 (7.43)$$

In addition we require that all the component values of the LC circuit be positive i.e.

$$L = \frac{1}{r + r^*} > 0 \tag{7.44}$$

$$C = \frac{r + r^*}{pp^*} > 0 (7.45)$$

The final requirement is that the remainder function be positive real i.e. the remaining terms of the admittance function describe a physical admittance. If these requirements are satisfied then an LC branch can be extracted from the admittance function and implemented as an admittance branch in the ladder network.

GL admittance branch

The GL admittance branch has an admittance function which can be expressed in rational function as

$$Y(s) = \frac{\frac{1}{L}}{\frac{1}{GL} + s} \tag{7.46}$$

This may be expressed in pole-residue form as

$$Y\left(s\right) = \frac{r}{s - p} \tag{7.47}$$

Where the pole and residue are both real. By equating coefficients of the functions, values of G and L can be identified We require that the component values of the GL circuit be positive i.e.

$$L = \frac{1}{r} > 0 \tag{7.48}$$

$$G = \frac{-r}{p} > 0 \tag{7.49}$$

The final requirement is that the remainder function be positive real i.e. the remaining terms of the admittance function describe a physical admittance. If these requirements are satisfied then a GL branch can be extracted from the admittance function and implemented as an admittance branch in the ladder network.

GC admittance branch

The GC admittance branch has an admittance function which can be expressed in rational function as

$$Y(s) = \frac{sG}{\frac{G}{C} + s} = G - \frac{\frac{G^2}{C}}{s + \frac{G}{C}}$$

$$(7.50)$$

This may be expressed in pole-residue form, including a constant term as

$$Y(s) = K + \frac{r}{s - p} \tag{7.51}$$

Where the pole and residue are both real. By equating coefficients of the functions, values of G and C can be identified We require that all the component values of the series GC circuit be positive i.e.

$$G = \frac{r}{p} > 0 \tag{7.52}$$

$$C = \frac{-r}{p^2} > 0 (7.53)$$

The final requirement is that the remainder function be positive real i.e. the remaining terms of the admittance function describe a physical admittance. If these requirements are satisfied then a GC branch can be extracted from the admittance function and implemented as an admittance branch in the ladder network.

Inductance branch

The inductance branch has an admittance function which consists of a pole at zero i.e.

$$Y(s) = \frac{1}{sL} \tag{7.54}$$

Thus in the pole-residue expansion we require a pole at zero. In addition we require that inductance be positive i.e.

$$L = \frac{1}{r} > 0 (7.55)$$

The final requirement is that the remainder function be positive real i.e. the remaining terms of the admittance function describe a physical admittance. If these requirements are satisfied then a inductance branch can be extracted from the admittance function and implemented as an admittance in the ladder network.

Capacitance branch

The capacitance branch has an admittance given by

$$Y\left(s\right) = sC\tag{7.56}$$

Thus in the pole-residue expansion we require a sC term (pole at infinity in the admittance function) with positive capacitance, C. The final requirement is that the remainder

function be positive real i.e. the remaining terms of the admittance function describe a physical admittance. If these requirements are satisfied then a capacitance branch can be extracted from the admittance function and implemented as an admittance in the ladder network.

Conductance (Resistance) branch, type 1

The conductance branch of type 1 is identified by a positive constant term, G, in the pole-residue expansion of the admittance. If the remainder function is positive real i.e. the remaining terms of the admittance function describe a physical admittance then a resistance branch can be extracted from the admittance function and implemented as an admittance in the ladder network.

Conductance (Resistance) branch, type 2

The conductance branch of type 2 may be found from the rational function form of the admittance i.e. if

$$Y(s) = \frac{a_0 + a_1 \left(\frac{s}{\omega_0}\right) + a_2 \left(\frac{s}{\omega_0}\right)^2 + \dots}{b_0 + b_1 \left(\frac{s}{\omega_0}\right) + b_2 \left(\frac{s}{\omega_0}\right)^2 + \dots}$$
(7.57)

then we can calculate the conductance, G as

$$G = \frac{a_0}{b_0} \tag{7.58}$$

7.2.4 **Brune Synthesis**

There are circumstances when the ladder network synthesis procedure described above fails i.e. a physical impedance/ admittance function results for which no viable series impedance or parallel admittance branch can be found. In this case the method described by Brune [15] may be applied to allow the process to proceed. Brune's method involves the use of a transformer which can be included in Spice simulations using the K element. The basic process is described here however the associated proofs of the properties of the functions at each stage will not be given. For further details see references [15] and [16].

The ladder network synthesis procedure ensures that poles at zero, poles at infinity, zeros at infinity, zeros at zero, poles on the $s=\pm j\omega$ axis and zeros on the $s=\pm j\omega$ axis have been removed from the impedance function. Brune's method then operates on this remainer function, $Z_r(s)$, as follows:

Stage 1. Find ω_0 such that the real part of the impedance $Z_r(s=j\omega_0)$ is a minimum. The minimum resistance value at this frequency is R_{min} .

Stage 2. Subtract R_{min} from $Z_r(s)$ to give the minimum resistance impedance function

$$Z_1(s) = Z_r(s) - R_{min}$$
 (7.59)

i.e. R_{min} is extracted as a series resistance.

The function $Z_1\left(s\right)$ is now purely reactive at w_0 i.e. $Z_1\left(\omega_0\right)=jX$. This reactance is set to be the reactance of an inductor, L_A where $L_A=\frac{X}{\omega_0}$. Note that this inducatance may be negative.

This series inductance is subtracted from $Z_1(s)$ to give

$$Z_2(s) = Z_1(s) - sL_A$$
 (7.60)

 $Z_2\left(s\right)$ has a zero of order 2 at $s=j\omega_0$ and we can write the admittance $Y_2(s)=rac{1}{Z_2(s)}$ as

$$Y_2(s) = \frac{1}{Z_1(s) - sL_A} = \frac{\alpha}{s^2 + \omega_0^2} + Y_3(s)$$
 (7.61)

From this we can identify a LC admittance branch where $L_B = \frac{1}{\alpha}$ and $C_B = \frac{1}{\omega_0^2 L_B}$

The remainder impedance $Z_3(s) = \frac{1}{Y_3(s)}$ after subtraction of the LC admittance branch has a first order pole at infinity and therefore a series inductance can be extracted i.e.

$$Z_r(s) = Z_3(s) - sL_C$$
 (7.62)

where L_C is negative if L_A is positive and vice versa. In addition to this it can be shown that the remainder impedance, $Z_r(s)$ is positive-real.




Figure 7.8 Initial Brune Synthesis Circuit




Figure 7.9 Final Brune Synthesis Circuit

This series of component identification leads to the circuit shown in figure 7.8 however this is not a physical circuit in that one of the series inductors L_A or L_B is negative. The three inductances may be combined into two positive inductors with a mutual inductance term as seen in figure 7.9. In this circuit the component values can be shown to be

$$L_1 = L_A + L_B$$

 $L_2 = L_C + L_B$
 $K = 1$ (7.63)

The inductances in the final Brune synthesis circuit are all positive and may therefore be simulated in Spice using L, C R and K elements. Since the remainder impedance is positive-real, the ladder network synthesis procedure can proceed.

7.3 Synthesis of non-positive real transfer functions

The process for one port synthesis requires that the impedance transfer function is a positive-real function. It may be the case that we need to synthesise a transfer function

which does not have this property. If this is the case then we can proceed by writing the transfer function as the difference between two positive real functions i.e.

$$Z_T(s) = Z_{T1} - Z_{T2} (7.64)$$




Figure 7.10 Synthesis of non-positive-real transfer functions

Each of the positive-real impedances may be synthesised by using the one port network synthesis process described in the previous section. The final transfer function may then be implemented in spice as seen in figure 7.10. It can be seen that the non-positive-real function may be found as $V(j\omega)$ where

$$V(j\omega) = I(j\omega) \left(Z_{T1} - Z_{T2} \right) \tag{7.65}$$

7.4 Application of the network synthesis in Spice cable bundle models

The Spice cable bundle models require the use of frequency domain transfer functions for the implementation of the propagation correction and for the transfer impedance coupling model. The propagation correction is expected to be a positive-real function as it represents the loss and dispersion in the modal propagation thus it will be implemented using a single port impedance. The transfer impedance functions however may have negative transfer resistance and/or inductance at certain frequencies and will therefore require a two port model for its implementation.
